会议简介

联合国人权理事会第46届会议举行期间,中国人权发展基金会、德国弗里德里希·艾伯特基金会、中国国际交流协会于2021年3月11日以视频形式举办主题为"文明交流互鉴与促进人权保障"的研讨会,邀请部分国家的社会组织代表和专家学者围绕"文明多样性背景下的人权理念""文明对话增进人权共识"等开展讨论,据此对第46届会议相关议题提出民间组织的解决方案。

Inclusiveness enriches the world, and diversity makes civilizations more brilliant. Different paths of human rights development emerge from colorful civilizations. The exchange and integration among different cultures has continuously enriched human rights practices around the world.

Today's world is facing many serious challenges, Such as public health crisis and economic recession. The protection of human rights and the shared future of mankind require trust and unity of people from different countries so that mutual understanding and common progress of different civilizations can be further promoted through exchanges and mutual learning. Civil society organizations, as representatives of the people, are an important player in public affairs and an important actor in global governance. Civil society organizations should play a significant role in eliminating barriers and misunderstanding, promoting people-to-people connectivity, improving global human rights governance, and contributing to the building of a community with a shared future for mankind.
